**NOTICE TO LESSEES AND OPERATORS OF FEDERAL OIL, GAS, AND SULPHUR
LEASES AND PIPELINE RIGHT-OF-WAY HOLDERS IN THE OUTER
CONTINENTAL SHELF, GULF OF MEXICO OCS REGION**

Conducting Platform Operations Before MMS Approval

This Notice to Lessees and Operators (NTL) is issued pursuant to 30 CFR 250.103. It makes provisions for you to conduct certain platform operations before you receive approval from the Minerals Management Service (MMS) Gulf of Mexico OCS Region (GOMR). Similar guidance was given in superseded NTL No. 2005-G18, effective October 7, 2005, as a result of the workloads incurred by the MMS GOMR because of Hurricanes Katrina and Rita. Since these workloads have not yet subsided, the MMS GOMR believes it necessary to reissue this guidance.

Platform Applications

In accordance with 30 CFR 250.900(b), you must submit an application and obtain MMS approval before you install a new platform or make major modifications or repairs to an existing platform. In accordance with 30 CFR 250.1727, you must submit an application and obtain MMS approval before you remove a platform.

However, pursuant to 30 CFR 250.142, the MMS GOMR has determined that you can perform the following platform installations, modifications, repairs, and removals after you submit the appropriate application but before you receive approval:

1. Installing a new platform that
 - a. has site-specific soil data;
 - b. meets High Consequence Criteria, L-1 (per Section 2 of API RP 2A, 21st edition);
and
 - c. has all connections with fatigue lives greater than 100 years.

2. Making major modifications and repairs to an existing platform that
 - a. has a deck height that meets the new design deck height requirements in Section 2 of API RP 2A, 21st edition;
 - b. meets High Consequence Criteria, L-1 (per Section 2 of API RP 2A, 21st edition);
 - c. has site-specific soil data;
 - d. has no corrosion, as evidenced by a coating system grade of A; and
 - e. has no Hurricane Katrina or Hurricane Rita damage

3. Adding a well to an existing platform that
 - a. was installed within the last 5 years;
 - b. has a deck height that meets the new design deck height requirements in Section 2 of API RP 2A, 21st edition; and
 - c. has an original platform design that provided for the additional well.

4. Converting a platform to a right-of-use and easement platform that
 - a. was installed within the last 5 years;
 - b. has a deck height that meets the new design deck height requirements in Section 2 of API RP 2A, 21st edition; and
 - c. is on a terminated lease, and all wells have been permanently plugged.

5. Removing a platform and performing site clearance where
 - a. the site is in a water depth less than 300 feet;
 - b. the platform will be completely removed at least 15 feet below the mudline;
 - c. if explosives will be used in the removal operation, you ensure that all charges are less than 50 pounds, use NOAA Fisheries observers, and follow all standard helicopter flight and observer clearance procedures for all detonations; and
 - d. you verify site clearance by trawling the 1,320-foot radius area.

Notify the MMS GOMR at least 48 hours before you begin any work under the provisions of this NTL.

Please be reminded that the MMS GOMR must review and approve all major repairs of damage resulting from Hurricanes Katrina and Rita before you conduct the work.
